Corn and soybean yields are standardized to 15% and 13% moisture respectively. Gross Income is estimated using \$6.00/bu for corn and \$14.00/bu for soybeans. Corn additionally receives a 5¢ dock per bushel per point of moisture over 15%; both crops receive a 2¢ dock per bushel per point of test weight under 54 lbs.
